In addition, the Board of Education reserves the right to require additional documentation to verify the statements set forth in this Affidavit. I agree to fully cooperate with any investigation by the School District of the facts set forth in or related to this Affidavit.

15. I understand that any false or fraudulent statements, answers or declarations contained in this Affidavit may render me personally liable for the payment of tuition for the entire school year or any portion thereof. Furthermore, I understand that the giving of false statements, answers or declarations in this Affidavit may subject me to prosecution.
